The City's Consolidated Annual Performance and Evaluation Report (CAPER) covers progress in carrying out the City's Fiscal Year 2023 Annual Action Plan for the use of HUD's Program Year 2023. The City is an entitlement city and is eligible to receive Community Development Block Grant (CDBG) and Home Investments Partnerships Grant (HOME) funds on an annual basis. This CAPER covers funding from the U.S. Department of Housing and Urban Development (HUD) used in the City's fiscal year July 1, 2023 – June 30, 2024. Annual Action Plan (AAP) FY23 is the second year AAP for the Five Year Consolidated Plan 2022-2026 (ConPlan). As required by HUD, the City has developed this CAPER using HUD's template. The CAPER is available for public comment and then submitted each year to HUD for review. The purpose of the CAPER is to report on the use of these funds during the Program Year.

Economic recovery has led to a more stable work environment, but affordable safe housing and homelessness issues continue to provide challenges. The City made significant progress in its housing rehabilitation efforts through the Minor Home Repair Program along several Public Service activities, including:

- Support for abused and neglected children.
- Homeless Outreach & Homeless Prevention Programs.
- Transitional housing, case management, budget counseling, and life skills training to promote self-sustainability.
- Comprehensive support services for survivors of domestic abuse.
- Housing and Emergency Assistance Programs.
- Shelter for homeless pregnant, and parenting young women aged 12 to 21, along with their babies.
- Nutritionally balanced meals and human services for low- and moderate-income elderly and disabled individuals.
- Critical outreach, financial assistance, and wraparound supports to address homelessness and help clients transition into stable housing.
- Operating costs for homeless family shelters.
- Assistance with utility disconnections and rental payments to prevent eviction and potential homelessness.

The City continued its code enforcement activities in low- to moderate-income neighborhoods to address blighting conditions

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

The 2023-24 Program Year was the second year of the 2022-26 Consolidated Plan. The City made progress across several goals outlined in that Plan. Some categories Actual Program Year accomplishments exceeded Expected Program Year. IDIS did not include the accomplishments for the code enforcement activity as well as development of new affordable homeowner housing units and single family homeowner rehabilitation. As a result staff entered the accomplishments for those activities.

CDBG funds were used to address the priorities, needs, and goals identified in the Consolidated Plan. The proposed budget for the PY 2023-24 Annual Action Plan was adopted into the City Budget by the City Council.

Funding priorities for the 2023-24 CDBG and HOME Programs were shaped by the results of citizen participation efforts, the City's Consolidated Plan, the adopted Comprehensive Plan, the Strategic Plan, the Capital Improvement Plan, and the City-wide Housing Study. The City relies on the CDBG Advisory Committee to evaluate competitive grant applications from eligible Public Service sub-recipients, while an internal evaluation committee assesses HOME housing development and rehabilitation proposals. The funded activities align with City Council priorities and the goals outlined in the City's adopted plans. Additionally, HOME proposals were solicited with an emphasis on promoting universal design and aging in place, in support of the City's Gold Standard Community for All Ages initiative through the Mid-America Regional Council (MARC).

Narrative

During the 2023-24 Program Year, 9,066 households were served. Of these, 79% were white, and the second largest racial group of families assisted was Black/African American (approximately 15%). Data shown in the table above did not capture the racial categories: American Indian/Alaskan Native & White (12), Asian & White (2), Black/African American & White (316), American Indian/Alaskan Native & Black/African American (3), or Other Multi-Racial (180). Of those totals- they include the data from the 24 Total Households assisted.

The above table and paragraph include data for the persons served through the City's Public Service Programs completed by CAPA, Community Services League, Hope House, Independence Meals on Wheels, Metro Lutheran Emergency Assistance, Mother's Refuge, Northwest CDC, Palmer Center Nutrition Program, reStart Inc., Salvation Army Crossroads and Salvation Army Emergency Assistance.

The racial and ethnic composition of families assisted is similar to the overall demographics of the City of Independence as reflected in the most recent American Community Survey data from the US Census

Narrative

The City of Independence received an allocation of \$851,251.00 in CDBG funding and \$535,865.00 in HOME funding for the 2023-24 fiscal year, the difference in the CDBG available and expended during the program year was unexpended prior year funding that was carried forward. Although the economy is approaching pre-pandemic levels, CDBG and HOME projects continue to face challenges due to rising costs. The increased prices of construction materials, labor, and the burden of higher property taxes and interest rates for homebuyers are contributing to slower expenditure of HOME funds. However, the City anticipates that at least four HOME projects will be fully completed and sold to qualifying homebuyers in the 2024-25 fiscal year.

Narrative

As mentioned above, funding priorities for the 2023-24 CDBG and HOME Programs were shaped by the results of citizen participation efforts, the City's Consolidated Plan, the adopted Comprehensive Plan, the Strategic Plan, the Capital Improvement Plan, and the City-wide Housing Study.

Public service projects selected for funding provided direct benefits to low- to moderate-income residents across the City of Independence. These programs were specifically targeted to qualifying residents whose household income falls below 80% of the median income, including the region's homeless population. Redevelopment planning and program administration efforts were distributed city-wide.

The allocation of 2023-24 CDBG (\$851,251.00) and HOME Program (\$535,965.00) within Independence was primarily determined by the annual citizen participation process, which identified needs and

priorities, and by committee evaluations of competitive grant applications submitted by eligible subrecipients and third-party developers. Fifteen percent (15% -\$127,687.00) of CDBG funds (Public Services) and HOME funds (excluding administrative funds - \$53,586.00) were awarded through a formal RFP process. Funding decisions were based on basic project eligibility, applicant capacity, the proposed benefit to the low- and moderate-income community, and the leveraging of other funding resources.

City-initiated activities, including code enforcement (\$195,000.00) and infrastructure improvements (\$358,314.00), made up the remaining projects. While these activities were informed by needs identified during the citizen participation process, they also reflected City Council priorities outlined in the City's Comprehensive Plan, Strategic Plan "Independence for All," and Capital Improvement Plan processes. These activities were concentrated in CDBG-eligible census tracts.

Code enforcement activities were conducted in deteriorating or deteriorated areas, where such enforcement, combined with public or private improvements, rehabilitation, or services, was expected to arrest the area's decline.

Leveraging

Explain how federal funds leveraged additional resources (private, state and local funds), including a description of how matching requirements were satisfied, as well as how any publicly owned land or property located within the jurisdiction that were used to address the needs identified in the plan.

The City did not have any HOME projects completed during this program year but is actively securing match contributions for the HOME program, focusing on projects that meet HUD's criteria for affordable housing activities, including those partially funded by federal sources. Current match contributions have come from projects such as homes built or rehabilitated by Truman Heritage Habitat for Humanity and OIKOS Development for income-eligible buyers. The primary sources of these match contributions would include:

- 1. Cash from Non-Federal Sources: This includes cash donations from project supporters or grants from state or local government funds directed toward eligible affordable housing projects.
- 2. Forgone Fees and Charges: This covers waived fees and charges for building permits, building permit plan reviews, and demolition permits required for eligible projects.
- 3. Real Property Donations: The appraised market value of donated real property for eligible projects has also been used as match contributions.
- 4. Donated Services and Materials: The value of donated design services, site preparation services, construction materials, and labor for eligible projects has contributed to the match.

No publicly owned land or property within the jurisdiction was used to address the needs identified in the plan for this program year, which is not applicable to the City of Independence.

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

The City did not meet its annual goals for both the HOME and CDBG projects during this period, primarily due to a lack of funding and the ongoing challenges posed by high construction material and labor costs. The Community Housing Development Organizations (CHDOs) managed to complete the rehabilitation of one (1) existing blighted single-family home, providing a homeownership opportunity to a low- to moderate-income family. Additionally, they have three (3) more homes nearing completion,

which will soon be available to eligible buyers. However, higher property taxes and interest rates pose significant barriers to the sale of these homes.

No new single-family home constructions were completed during this period. However, Truman Heritage Habitat for Humanity has recently purchased 12 vacant lots in the City and plans to begin construction on at least two of these homes in the 2024-25 period.

On the CDBG side, the City's Minor Home Repair program saw a decrease in activity due to the rising costs of labor and construction materials and the decrease in funding. With the available funds, only eight homes were completed for low- to moderate-income homeowners during this time period

Discuss how these outcomes will impact future annual action plans.

There are ongoing situations where projects span multiple grant years, starting in one and concluding in another. As a result, annual numbers may not fully reflect progress, but over a two- to three-year period, these amounts should balance out. The City will continue to rely on projections from subrecipients when estimating the number of assisted households. Additionally, the City will consistently monitor the goals outlined in the Consolidated Plan and make adjustments as necessary to ensure progress and alignment with long-term objectives.

Narrative Information

CDBG funds were allocated for eligible minor home repair activities, while HOME funds were directed toward the production of single-family homes for low- to moderate-income (LMI) homeownership opportunities. Data from the Minor Home Repair program indicates that the homeowners who received assistance were either in the low- or extremely low-income categories. Regarding single-family home production funded by HOME, two households were in the extremely low-income category, and two households were in the moderate-income category.

Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

The City has identified three primary causes of homelessness: economic challenges (such as low or no income), family-related issues (including domestic violence, death of spouse/partner), and housing shortages (specifically the lack of affordable housing). Additionally, chronic mental and physical health conditions have been recognized as contributing factors.

In response, the Community Engagement Unit of the Independence Police Department (IPD), with assistance from several School Resource Officers, has joined forces with regional partners to conduct monthly outreach services for homeless individuals. These efforts include collaboration with organizations such as Comprehensive Mental Health, the VA, Community Services League, and the Heartland Center for Behavioral Change.

During these monthly outreach initiatives, numerous individuals at various locations were contacted and provided with essential resources. These services ranged from case management, meals, hygiene, vital documentation, critical health and mental health support and emergency shelter and housing vouchers.

The City of Independence, along with local homeless service providers, remains actively involved with the HUD Continuum of Care (CoC) program through the Greater Kansas City Coalition to End Homelessness (GKCCEH). This involvement includes providing street outreach services, supportive services, and emergency and permanent shelter.

Addressing the emergency shelter and transitional housing needs of homeless persons

The following Public Services Programs focus on addressing the emergency shelter and transitional housing needs of homeless individuals in the City of Independence.

Child Abuse Prevention Association (CAPA) (\$13,541.91) Healthy Families Jackson County provides counseling for low-income families experiencing housing insecurity, many of whom live in affordable housing communities. The long-term goal is to prevent child abuse, neglect, and other adverse childhood experiences (ACEs) by creating a healthy and safe home environment for children. This is achieved by working with parents to help them identify their goals and needs. The program's success is

measured by an increase in the presence of five protective factors: family functioning and resiliency, social-emotional support, concrete support, knowledge of child development and parenting, and nurturing.

Community Services League (\$13,546.91) Homeless Outreach and Prevention Program supports homeless residents or those at risk of losing their housing by offering emergency relief for urgent and short-term needs, such as temporary housing, rent and utility assistance, food, clothing, and medications. Additionally, the program helps residents identify long-term housing solutions through coaching and case management.

Hope House (\$5,000.00) – Emergency Food Project - offers direct support to adults and children who have become homeless due to domestic violence. They provide healthy and nutritious meals in a safe environment. During the 2023-24 year, a total of 854 clients benefited from this program.

Metro Lutheran - (\$8,000.00) - Emergency Assistance provides housing and emergency services to households in the area facing homelessness. They work to prevent homelessness by offering assistance with rent and utilities, food, transportation, and providing case management. Additionally, they offer homebuyer education for up to two years and employment counseling to support long-term stability and success.

Mother's Refuge (\$16,701.01) -Shelter and Services for Homeless Moms and Babies - offers shelter and education to homeless, pregnant women to help them build successful lives. They provide comprehensive services designed to prevent future homelessness, including a safe home, meals, transportation, individualized case management, therapy, and hands-on life skills training. Mother's Refuge has also launched a transitional living program for homeless women aged 18 and older, offering apartments and extended care for the first five years of a child's life. They are currently working on adding more family apartments, which are expected to be available by 2025.

restart (\$12,500.00) Street Outreach Services provide essential outreach, financial assistance, and comprehensive support to address the root causes of homelessness and help clients transition into stable housing. As the entry point into reStart's continuum of care, these services offer food, shelter, hygiene kits, transportation, and other necessities to individuals experiencing homelessness.

Salvation Army -(\$13,546.91) - Crossroads operates the only family emergency shelter in Eastern Jackson County. CDBG funding was utilized to help cover operating costs, ensuring a safe and clean environment for families in need. The shelter remains at full capacity at all times and reopened in the spring of 2024 with newly updated private family apartments.

Salvation Army - (\$11,546.91) - Emergency Assistance Program offers housing and emergency services to households in the area experiencing homelessness. They work to prevent homelessness by providing aid such as rent and utility assistance, food, and transportation. The program also includes case management, homebuyer education for up to two years, and employment counseling to help individuals

and families achieve long-term stability.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

Currently, the City does not have a specific program designed to address this situation. Instead, the City of Independence participates in the Greater Kansas City Continuum of Care, which serves as the primary mechanism through which the City and its network of local service providers assist homeless individuals in transitioning to permanent housing and independent living. Additionally, the City has provided CDBG Public Service funding to local non-profits such as Salvation Army Crossroads, Salvation Army Emergency Assistance, Hope House, reStart, and Metro Lutheran Emergency Assistance to help meet some of these needs.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

To facilitate the transition from homelessness to permanent housing, Community Services League (CSL) and Metro Lutheran Emergency Services (MLM) offer up to three years of housing and financial counseling resources to help clients achieve long-term success and prevent the recurrence of homelessness.

In addition, the City has had success with the Independence T.O.G.E.T.H.E.R. program. This program was launched as a partnership between the City of Independence and the Community Services League in March of 2023. This initiative addresses two key community issues: assisting residents experiencing homelessness or housing instability and contributing to community beautification by reducing roadway litter.

Participants in the program are employed as crew members to help clean up litter in the community while receiving coaching to move toward permanent housing. T.O.G.E.T.H.E.R. stands for Together Opportunities Grow Everyone To Help Empower Resiliency. The program is funded through a \$100,000 grant from the City of Independence's allocation of federal American Rescue Plan dollars.

Employees are paid \$12 per hour, with wages provided at the end of each shift. Additionally, \$3 per hour is placed in escrow for a housing savings fund. After every 100 hours worked, employees can request \$300 to be paid toward housing expenses such as daily, weekly, or monthly motel rentals, past-due rent and utilities, deposits on new utility services or apartment rentals, or other costs that promote permanent, stable housing.

Participants are also provided with proper work attire and supplies, including high-visibility safety vests. Breakfast and lunch are offered to employees during their shifts. The Community Services League (CSL) works to connect participants with additional housing resources and programs, assists in securing permanent jobs, and helps them obtain the necessary state-issued identification and documents needed to enter the workforce.

CR-30 - Public Housing 91.220(h); 91.320(j)

Actions taken to address the needs of public housing

Independence Housing Authority (IHA) of Independence, MO plays a crucial role in helping the city address issues of affordability and housing security, particularly for low-income residents. By providing affordable, stable housing options, public housing reduces the pressure on the rental market, helping to prevent displacement and homelessness. This stability not only benefits the residents directly but also contributes to the overall economic health of the city. When residents have secure housing, they are more likely to maintain employment, invest in their communities, and participate in local economies, which can lead to increased economic activity and tax revenue for the city.

The IHA oversees 528 public housing units and 1,647 Housing Choice Vouchers, actively working to address the affordable housing shortage evident in their waiting list data. To tackle this challenge, IHA employs several key strategies: optimizing affordable housing availability through ongoing program enhancements and efficient management practices; securing additional resources to replace public housing units and undertake mixed-finance, mixed-income redevelopment projects; and expanding housing opportunities by applying for additional vouchers as they become available, including those specifically designed for groups such as the elderly, disabled, veterans, homeless, and foster youth.

Moreover, public housing can enhance social cohesion and promote inclusive urban development. Well-planned public housing projects can create vibrant, diverse communities by integrating affordable housing with essential services, green spaces, and public transportation. This fosters social interaction and reduces segregation, contributing to safer and more resilient neighborhoods. Additionally, public housing can serve as a catalyst for revitalizing underserved areas, attracting investments and improvements in infrastructure, which can uplift entire communities and drive sustainable urban growth

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

The Independence Housing Authority (IHA) participates in the Housing Choice Voucher (HCV) program which extends beyond rental assistance to support low-income families in achieving homeownership. Through the HCV Homeownership Program, eligible participants can use their vouchers to help cover mortgage payments and other homeownership costs, making it feasible for families to transition from renting to owning a home. This program not only offers financial assistance but also provides counseling and education on budgeting, credit, and the home-buying process, equipping participants with the tools needed for sustainable homeownership. By enabling families to build equity and secure long-term housing stability, the HCV program contributes to greater economic independence and strengthens communities by fostering stable, invested homeowners.

Actions taken to provide assistance to troubled PHAs

The PHA is not designated as troubled, so this status does not apply (N/A).

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

The City continues to support redevelopment in low- to moderate-income Census Tracts through the Building Permit Fee Waiver Program. Demonstrating its commitment to revitalizing distressed areas, the City of Independence approved Resolution No. 6815, which waives building permit fees—including fees for building, electrical, mechanical, and plumbing work—for new single-family home construction and significant rehabilitation projects within designated areas. This program aims to attract infill and redevelopment investments, reduce neighborhood blight, and promote well-designed, planned redevelopment. By removing financial barriers, the program incentivizes property owners to contribute to the revitalization of these communities.

The City continues to oversee the Southwest Independence Redevelopment Plan (SWIRP) and Tax Abatement Program, aimed at revitalizing the Southwest Independence 353 Redevelopment Area. This initiative addresses residential blight and encourages reinvestment by offering tax abatements to property owners who rehabilitate their properties according to the Plan and Guidelines. The redevelopment area includes several low-to-moderate income Census Tracts, making this program a crucial tool for promoting economic development and improving housing.

The City remains actively engaged in discussions to update the Unified Development Ordinance (UDO), with a focus on affordable housing and addressing blighting conditions. In collaboration with the Englewood Neighborhood Association, the City is developing a redevelopment plan that prioritizes affordable housing solutions. Key components of this plan include promoting accessory dwelling units (ADUs) and reducing barriers to affordable housing through initiatives like neighborhood pocket cluster developments. These efforts aim to create more inclusive, sustainable communities by expanding housing options and revitalizing areas in need of investment.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

The City derives strategies and priorities for housing and community development through the City's Consolidated Plan, the City's Comprehensive Plan, City-wide Housing Study, and the City's Strategic Plan and aligning projects with those key outcome areas identified.

The primary challenge in addressing all identified needs, particularly those deemed high priorities, is the general lack of funding resources available to both public and private agencies serving low and moderate-income residents. This funding shortfall significantly hampers efforts to meet the community's needs. Compounding this issue, the City, as an entitlement community, is ineligible for state CDBG or HOME programs, further limiting the financial support that could otherwise be leveraged

to enhance services and address critical housing and development concerns

In addition to providing direct financial assistance for unmet needs identified as priority during the consolidated planning process, the City continued to work toward building community capacity to overcome barriers through the following efforts.

Housing and Homelessness – The City continued to work with Truman Heritage Habitat for Humanity and Oikos Development Corporation on construction or rehab of single-family homes for sale to 50% and 80% of area medium income families, respectively. The City's Minor Home Repair Program continues to assist low- to moderate-income homeowners with much needed home repairs to extend their longevity and to increase their safety and livability. Finally, the City continued its code enforcement efforts in deteriorating or deteriorated areas where such enforcement, together with public or private improvements, rehabilitation, or services to be provided, may be expected to arrest the decline of the area.

Homelessness – The City continues its efforts in meeting the underserved needs of the homeless population through annual financial support and participation in the Greater KC Continuum of Care. CDBG Public Service funds were allocated to the Salvation Army Crossroads Shelter, Community Services League (CSL), and Mother's Refuge Transitional Housing to assist with staff cost. As mentioned in the CR-25 Section, the City implemented the Independence T.O.G.E.T.H.E.R. program, continued the ARCH program and the Eastern Jackson County Shared Services Initiative (EJCSSI) to continue to work together in addressing the myriad issues stemming from and contributing to homelessness.

Economic Development – The City continued the administration of three (3) 353 development area plans and tax abatement programs. These programs are designed to address residential blight and spur reinvestment for owners of real property as an incentive to reinvest in and rehabilitate their properties in accordance with the Plan and Guidelines. The Independence Chamber of Commerce continues to assist the Ennovation Center with professional support and the provision of certain development incentives to promote new micro-business start-ups in Independence. The Ennovation Center is a dynamic business development incubator spanning over 28,000 square feet, featuring a range of specialized facilities and services to support the growth and success of its clients.

Supportive Services – The City provided CDBG funding through a competitive request for proposal process for a variety of public service activities intended to create or expand services that target underserved needs in the community.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

The Community Development Department adheres to HUD's "Guidelines for the Evaluation and Control of Lead-Based Paint Hazards in Housing," 2012 Edition, ensuring all housing projects funded by CDBG and HOME are assessed for lead-based paint hazards. Oikos Development Corporation and Truman Heritage Habitat for Humanity, both CHDOs working with HOME funds, rigorously test all homes for

lead-based paint and follow strict protocols for control and abatement.

Similarly, CDBG-funded home repair programs test for lead when paint is disturbed, and remediation is required if hazards are found. Lead-based paint clearance reports are filed with the Department of Health and Senior Services, with copies sent to the City.

Additionally, the City provides Lead Hazard brochures to all federally assisted home buyer projects at the application stage, and includes lead-based paint information in its Landlord Tenant Guide, which landlords are required to give to new

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

The City of Independence has continued to utilize CDBG and HOME funds to undertake activities aimed at reducing poverty and enhancing the quality of life for residents. These efforts, both direct and indirect, are focused on improving the living conditions of low- and very low-income populations.

The City coordinated the implementation of its existing affordable housing programs, including the HOME-funded single-family housing development, rehabilitation projects, and the Minor Home Repair Program. These initiatives were closely aligned with the efforts of social service agencies dedicated to supporting individuals and families living below the poverty line.

Key partners in these efforts included CAPA, Community Services League, Hope House, Independence Meals on Wheels, Metro Lutheran Emergency Assistance, Mother's Refuge, Northwest CDC, Palmer Center Nutrition Program, reStart, Inc., Salvation Army Crossroads, and Salvation Army Emergency Assistance. These organizations provide vital support services that help reduce the number of families living in poverty.

For the 2024-25 fiscal year, the City has approved and awarded HOME-ARP funding. This funding will be allocated to rental assistance and supportive services aimed at helping homeless individuals, those at risk of homelessness, and households in other vulnerable categories achieve stable housing and prevent future homelessness.

Projects that indirectly impact poverty include those that upgrade the community's infrastructure and provide safe, decent, and affordable housing. For example, the Minor Home Repair Program addresses critical health and safety issues for low- to moderate-income households. Without the CDBG-funded home repairs, many of these homeowners would be at risk of living in substandard conditions or even facing homelessness.

The City of Independence has allocated \$50,000 to a weatherization program aimed at helping low-income homeowners improve energy efficiency in their homes. Truman Heritage Habitat for Humanity has been chosen to implement this program in collaboration with the City of Independence Power & Light Department. Through this initiative, qualifying low-income households can receive up to \$7,500 in

direct weatherization services to help reduce their energy bills.

As highlighted in the CR-25 Section, the Independence T.O.G.E.T.H.E.R. program has been recognized as an early success in helping homeless and near-homeless individuals regain stability. Additionally, the City has continued to support agencies that provide case management and other supportive services aimed at assisting low-income populations.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The City is committed to forging partnerships with a wide range of community agencies, irrespective of their funding sources, to maximize our impact on local needs. Throughout the program year, City staff actively engaged with corporate, non-governmental organizations, and individuals to establish institutional frameworks that support the evolving needs of our community.

Our continued collaboration with public service agencies, neighborhood revitalization organizations, and housing providers reflects a shared commitment to the goals of the Community Development Block Grant (CDBG) and HOME programs. By working together, we enhance our ability to meet these goals and improve the quality of life for our residents.

Through our involvement with the Mid-America Regional Council (MARC), the City supports regional efforts to provide quality early education for all young children, strengthen the workforce system, increase the supply of affordable housing, and support vulnerable families and older adults through nutrition incentives and Area Agency on Aging services.

Additionally, the City has deepened its partnerships with local builders and contractors to promote residential in-fill housing and the substantial rehabilitation of single-family homes deemed unsafe or dangerous. These collaborations, along with the City's heightened enforcement of anti-blight regulations, have led to a notable increase in the number of residential properties being repaired and revitalized.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

The City's Community Development Department is dedicated to fostering a more livable and vibrant community by implementing best practices in urban planning and design. Focused on neighborhood revitalization, the City continuously collaborates with various City departments, organizations, outside agencies, and institutions to achieve its mission.

The City partners with key organizations, such as the Independence Housing Authority, Truman Heritage Habitat for Humanity, and OIKOS, as well as other non-profits, to address affordable housing needs and related community issues throughout the program year. These partnerships are instrumental in producing affordable housing and supporting community development goals.

Active Participation in Regional Committees

City staff actively contribute to several regional committees focused on housing, transportation, and services that impact low- and moderate-income (LMI) populations. These committees include:

Independence Health & Animal Services: Along with the City held a Social Service Summit meeting in which several of the area's community agencies presented their program resources to help the City's most vulnerable population.

Community For All Ages: An age-friendly initiative that raises awareness about the needs of an aging population. It offers workshops, resources, and a structured recognition program to help local jurisdictions create age-inclusive policies, practices, and infrastructure. The initiative ensures that older adults are understood, valued, and involved in enhancing community quality of life.

Truman Heartland Community Foundation: This foundation seeks to improve communities in Eastern Jackson County by promoting private giving for public good, thereby enhancing local quality of life.

First Suburbs Coalition: A committee that focuses on preserving, reinvesting in, and revitalizing neighborhoods where the majority of housing was built between post-World War II and 1970. The goal is to maintain a high quality of life for current residents and future generations.

Mobility Advisory Committee: This committee addresses issues related to improving mobility, specifically for ADA and non-ADA paratransit services in the Kansas City region.

Regional Transit Coordinating Council: Focuses on regional transit planning, coordination, and the implementation of transit priorities to enhance transportation access.

Sustain Places Policy Committee: Composed of local elected officials, community development experts, equity organizations, and environmental advocates, this committee collaborates with local communities to update and implement land-use strategies that support transportation, equity, environmental sustainability, and conservation principles.

Greater Kansas City Continuum of Care: As the lead agency for Jackson County, Missouri, this organization coordinates efforts among stakeholders to address homelessness and related issues.

Southwest Independence Redevelopment Corporation: Oversees the Southwest Independence Redevelopment Plan, promoting revitalization throughout the area.

Enhancing Service Delivery to LMI Areas

Through these partnerships and committee involvements, the City has explored more effective ways to deliver and coordinate services to low and moderate-income areas. These collaborative efforts ensure that community development initiatives are well-rounded, inclusive, and responsive to the needs of all residents.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

Impediments to Fair Housing Choice, as defined by HUD, are any actions, omissions, or decisions that restrict housing choice or the availability of housing options based on race, color, religion, sex, disability, familial status, or national origin.

The City is currently in the second year of implementing its 2022 Affirmatively Furthering Fair Housing (AFFH) Plan. This plan places significant emphasis on understanding the challenges faced by those living in areas of concentrated poverty and communities of color, specifically in Racially and Ethnically Concentrated Areas of Poverty (R/ECAPs). The analysis within the plan explores strategies to enhance access to opportunities through improved education, transportation, employment, and environmental conditions.

Additionally, the City amended its Unified Development Ordinance (UDO) concerning homeless shelters. This amendment aims to reduce the formation of homeless camps, which have strained City resources, while also providing more consistent support and resources to individuals in need.

City staff continued to utilize landlord/tenant regulations, the Rental Ready Program, and the Vacant Structure Registration Program to mitigate the impact of housing impediments. As part of the Rental Ready Program, all rental units must pass a basic health and safety inspection every two years. Landlords are required to hire a qualified housing inspector from the City's approved list to conduct these inspections, which cover nine essential health and safety items. If a unit fails the inspection, the landlord must address any deficiencies and have the unit reinspected. A unit cannot be rented without an approved inspection form.

Additionally, as part of the program, landlords are required to provide tenants with a copy of the landlord/tenant guide. This guide includes a summary of applicable laws, federal and state regulations, Fair Housing Laws, the EPA Lead Paint Guide, and Lead Paint Disclosure requirements.

City staff continues to actively participate in the City's Human Relations Commission, which was established to foster mutual understanding and respect among all ethnic, racial, and religious groups. The Commission also works to discourage and prevent discrimination based on gender, age, disability, or familial status. Additionally, the Commission cooperates with federal, state, and municipal agencies, as well as non-governmental organizations, to achieve its goals. Over the past year, the Commission met seven times, discussing topics ranging from disability awareness and the houseless community to the use of translation services.

During the 2023-24 fiscal year, the City utilized existing systems, standards, and procedures to monitor key areas of program administration and regulatory compliance, which are essential to achieving the goals of the Consolidated Plan and program objectives. These areas of focus included minority business outreach and comprehensive planning requirements. Specifically, the City monitored the following:

- 1. Program Performance Review: This included evaluating national objectives, eligible activities, contract objectives, scope of work, contract schedules, and contract budgets.
- 2. Financial Management Practices: This involved reviewing the accounting system and internal controls to ensure proper financial oversight.
- 3. Record Keeping and Reporting Practices: Ensuring accurate and thorough documentation and reporting.
- 4. General Management Practices: Overseeing overall management efficiency and effectiveness.
- 5. Non-Discrimination Compliance: Monitoring adherence to non-discrimination policies.

The City of Independence monitors sub-recipients either through desk monitoring or on-site visits, based on the following criteria:

- New Sub-recipients: Those new to the program, or those with high staff turnover or who have not been funded in the prior 2-3 years, receive an on-site monitoring visit.
- Sub-recipients with Reporting Issues: Any sub-recipient who failed to report timely or had difficulty reporting accurately in the prior year will receive an on-site monitoring visit.
- Consistently Compliant Sub-recipients: Sub-recipients who have been consistently funded without reporting delays or errors will be desk monitored or receive on-site monitoring on an every other year basis.

For the 2023-24 fiscal year, the City of Independence conducted on-site monitoring of four CDBG Public Service grant sub-recipients: Community Services League, Metro Lutheran Ministry, reStart, and Salvation Army – Emergency Services. Additionally, one NSP-funded activity, Mt. Washington Senior Apartments, was monitored.

The purpose of these monitoring visits was to ensure that the sub-recipients had implemented and administered CDBG-funded activities in accordance with applicable Federal requirements. Particular attention was paid to compliance with eligibility and National Objective requirements, conformance to the Subrecipient Agreement with the City, financial & record keeping management systems, insurance coverage, non-discrimination policies, and actions to further fair housing.

The above items are determined based on the agency, not the program. (i.e. : if an agency is funded for something with a different scope of work, it is still considered consistent funding as the same client intake is generally required).

In accordance with the City of Independence Citizen Participation Plan, a notice regarding the availability for review and comment of the annual Consolidated Annual Performance Evaluation Report (CAPER) was published in the locally circulated Independence Examiner, as well as posted on the City of Independence Community Development webpage, and at public libraries and community centers. This notice provided details on how to obtain a copy of the draft CAPER via the web, in person, or by telephone request, and included instructions for requesting special accommodations to participate in the review process. Additionally, the CAPER was made available for public comment in multiple languages.

The public comment period for the 2023-24 CAPER will begin on Friday, September 6, 2024, with a legal advertisement in the Independence Examiner, and will conclude at 5:00 PM on Wednesday, September 25, 2024. The public is encouraged to provide feedback on the CDBG program as a whole, as well as on the 2023-24 CAPER. All proposed actions under the Entitlement Program were reviewed for compliance with HUD regulations, ensuring that they meet a national objective, constitute an eligible activity, and address one of the goals established by the City within its Consolidated Plan.

The City did not allocate HOME funds for rental housing projects during the 2023-24 Program Year. However, it continues to manage one existing HOME-funded rental housing project, Mt. Washington Senior Apartments.

In compliance with HOME Program requirements, on-site inspections were carried out during the 2023-24 Program Year for HOME-assisted rental projects.

Washington Senior Apartments (4 units), City staff reviewed inspection summary reports, including income certification and verification, household size and eligibility, and annual recertification requirements. These reports, provided by Sherman Associates under an agreement with MHDC, revealed no material deficiencies.

All HOME-funded developments are required to have an Affirmative Marketing Plan. The PR-09 Report shows \$7,000.52 of Program Income by Voucher # 5419372 was received during 2023-24 program year. This funding was awarded to a CHOD during our HOME RFP allocation process and will be used on a single family rehabilitation for homeownership opportunity that is currently in the construction phase.

HOME Projects and Funding – As previously mentioned, the housing market, construction material cost,

labor cost as well as the lingering supply chain issues slowed the expenditure of HOME funds It's anticipated that four (4) ongoing projects will be completed in 2024-25 program year and the single family homeownership projects awarded 2024-25 HOME funds will begin.

HOME ADMIN – The City expended \$39,612.06 in HOME for HOME grant administration, which totaled 7.3% of the HOME entitlement funds, below the 10% maximum.

HOME CHDO – The City expended \$23,296.76 of Community Housing Development Organization (CHDO) Operating funds to two (2) different CHDOs operating within the City. These CHDO Operating funds were from 2020-21 and 2021-22 Program Years.

In recent years, the City of Independence has faced significant challenges in its housing market due to soaring land values. This trend, combined with the relatively lower income levels of the city's residents compared to neighboring areas, has created a substantial barrier to affordable housing. The primary issue is the growing disparity between the high cost of housing and the limited economic resources available to residents.

Despite the city's aging housing stock, the low incomes of many residents, particularly those in older parts of the community, present further obstacles to housing affordability. However, the City is actively addressing these challenges through several strategic initiatives.

The City regularly reviews and updates local development standards to ensure they do not inadvertently hinder affordable housing efforts. These standards are designed to increase opportunities for developing new affordable housing and improving existing housing conditions.

The City of Independence is committed to ongoing efforts to identify and mitigate barriers to affordable housing within its jurisdiction. This includes pursuing available funding for job creation, down payment assistance and housing rehabilitation. The City also collaborates with Community Housing Development Organizations (CHDOs) and both non-profit and for-profit housing developers to promote high-quality housing standards.

Through the utilization of HOME funds, the City supports various activities, including the acquisition and rehabilitation of affordable homes for homeownership and providing direct financial assistance to low-and moderate-income homebuyers. These HOME funds are specifically targeted at households with incomes below 80% of the Area Median Income (AMI).

The City continues to partner with organizations like Truman Heritage Habitat for Humanity and Oikos Development Corporation to construct or rehabilitate single-family homes for families earning 50% to

80% of the AMI. Additionally, the City's Minor Home Repair Program assists low- to moderate-income homeowners with essential repairs, helping to extend the longevity, safety, and livability of their homes.

Finally, the City has sustained its code enforcement efforts in areas showing signs of deterioration. By combining enforcement with public and private improvements, rehabilitation, and other services, the city aims to arrest and reverse the decline in these neighborhoods.
